The following guidelines must be followed whenever an entrant enters an electrical vault, manhole, storm drain, sewer, sump, or other permit confined space(s):

- All workers must receive confined space training prior to entering a permit confined space.
- Workers must receive approval from their supervisor to enter a permit confined space.
- Confined space atmospheres will be monitored for oxygen (O₂), lower explosive limit (LEL), carbon monoxide (CO) and hydrogen sulfide (H₂S). Air measurements must be taken prior to the use of a ventilator fan, after the ventilator fan is used, and before any worker enters the space.
- Once it is safe to enter, air-monitoring equipment must be used to monitor the space. Periodic readings must be recorded throughout the duration of work at 30-minute intervals.
- Atmospheric levels of O₂, LEL, CO and H₂S must be within an acceptable range before workers enter or continue to work in any confined space (see chart below):
- All permit confined spaces must be ventilated continuously using a ventilator fan while workers are in the space.
- Workers must IMMEDIATELY exit any confined space if the instrument alarms, if they become dizzy, nauseous, groggy, feel ill or suspect that a condition in the space jeopardizes their health.
- One worker (Attendant) shall remain outside the confined space while workers are in the space. The attendant must remain in communication with all confined space workers.
- The Safety and Environmental Affairs (S&EA) department and Warner Bros. Fire Department must pre-approve any welding operations, hot work, or the use of chemicals in a confined space.
- UNDER NO CIRCUMSTANCE SHALL ANY ATTENDANT OR OTHER UNTRAINED WORKER ENTER A CONFINED SPACE TO RESCUE A DOWNED WORKER. CALL 911 IMMEDIATELY, THEN CALL 4-3333 or 818-954-3333 AS SOON AS POSSIBLE.
